		Pump Track/Skate Park – Meeting had taken place with Lyn Richardson regarding locations that may be available. Noted that a makeshift track has been made by the children which shows the need for this facility. Lyn Richardson to check if the kickabout area would be a suitable location. It was suggested that a pop-up pump track could be installed to see if there is a need. Cost is likely to be around £70k and grants are available.							
		Highways – Meeting has still not happened. Cllr. Hughes was asked to provide Westmorland and Furness Councils policy on footways which she agreed to do.							
		Village Square – A number of plans have been drawn up over a number of years. No work has ever been undertaken, and the next plan will be a public consultation. It was noted that the square is very different now to when the first plans were drawn up. The council now needs to understand what residents want. A public meeting was suggested, and it was felt that this was a good idea.							
		Allotment Lease – Noted that a meeting had not taken place as yet and will be arranged as soon as possible. Noted that the area outside the allotment has now been filled with gravel.							
		Cllr. Hughes noted the Call for Sites map with regard to the new local plan is now live.
